## Processing of Data for Navigation Purposes

The IT systems and software procedures responsible for the functioning of this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. These are pieces of information that are not collected to be associated with identified individuals, but which, by their very nature, could, through processing and association with data held by third parties, allow users to be identified.

Among the information that can be collected are

- IP addresses, browser types or operating systems used,
- addresses in URI (Uniform Resource Identifier) notation,
- domain names and addresses of websites from which access or exit occurred (referring/exit pages),
- the time of the server request,
- the method used,
- and information about the response obtained, additional information on user navigation within the site (see also the section on cookies), and other parameters related to the user's operating system and IT environment.

Such data may also be used to ascertain responsibility in the event of cybercrimes against the site.

## Use of Cookies

The following information is provided to users in compliance with the Italian Data Protection Authority's decision of May 8, 2014, "Identification of simplified methods for information and acquisition of consent for the use of cookies."

### What are Cookies?

Cookies are small text strings that a website can send to your device (be it a PC, notebook, smartphone, or tablet; they are generally stored directly on the browser used for navigation).

The same website that transmitted them can then read and record the cookies stored on the same device to obtain various types of information. What types of information? Each type of cookie serves a specific purpose.

## Types of Cookies

There are two fundamental macro-categories, each with different characteristics: technical cookies and profiling cookies.

**Technical Cookies:** These are usually necessary for the proper functioning of the website and for enabling navigation; without them, you may not be able to view pages correctly or use certain services. For example, a technical cookie is indispensable to keep the user logged in during a visit to a website or to store language and display settings.

Technical cookies can be further classified as:

- **Navigation cookies:** Ensure normal navigation and use of the website (e.g., enabling purchases or authentication for restricted areas).
- **Analytics cookies:** Considered technical cookies only when used directly by the site manager to collect aggregated information on the number of users and their interaction with the site.
- **Functionality cookies:** Allow the user to navigate based on selected criteria (e.g., language, selected products) to improve the service provided.
- **Profiling Cookies:** These are more advanced! They profile the user and are used to send advertising messages aligned with the user's preferences during navigation.

Cookies can also be categorized as:

- **Session cookies:** Deleted immediately upon closing the browser.
  - **Persistent cookies:** Unlike session cookies, these remain within the browser for a specific period. They are used, for instance, to recognize the device connecting to the site, facilitating user authentication operations.
  - **First-party cookies:** Generated and managed directly by the website manager on which the user is browsing.
  - **Third-party cookies:** Generated and managed by entities other than the website manager (usually under a contract between the site owner and the third party).
